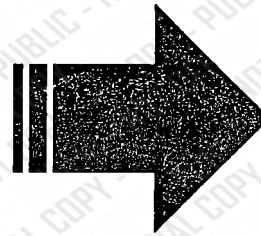

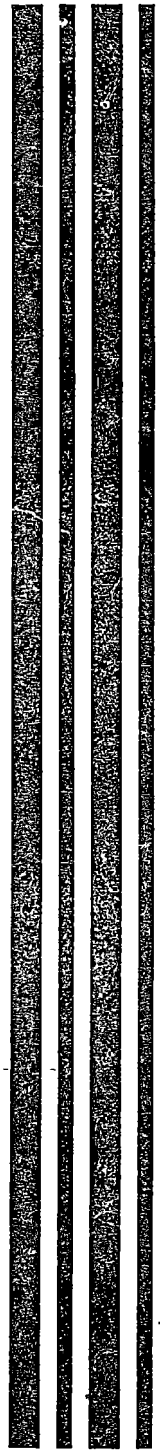

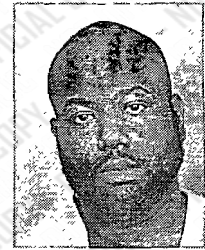

Between December 2018 and October 2019 it was confirmed that SS has not been attending school and had not made contact with any of her family members.

Before me this date personally appeared GRANIT, ADAM (582) who being first duly sworn deposes and says that on 22 day of October, (year) 2019 at 8121 SW 24TH CT 304, DAVIE, FL 33324 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On February 25, 2019, City of Sunrise Missing Juvenile Alerts were distributed to multiple law enforcement jurisdictions through United States. Additionally, A Missing Juvenile Alert was sent to the Sunrise Police Department Facebook page and released to the Public.

On February 26, 2019, Belinda Mosely (The Sister of SS) contacted Sunrise Police Detectives and advised that her sister SS had been seen at the 7-11 located at 8630 W State Road 84 Davie, Florida. Belinda advised that SS had come into the store at about 1:00 AM and was with two unknown black males. One of the black males has shoulder length dreads while the other is heavy set with a bald head. According to Belinda, SS walked into the store and then noticed that the store clerk was a friend of Belinda's and that he was aware that SS was missing. SS then attempted to shield her face and exited the store quickly while covering her face in an effort not to be recognized. All subjects possibly left in a black in color Dodge Challenger. There was no license plate number observed on the vehicle.

On February 27, 2019 Sunrise Police Detectives responded to the 7-11 located at 8630 W. State Road 84. Sunrise Detectives met with the manager of the store. The 7-11 manager located video footage from the previous night and showed it to detectives. In reference to the video footage, two black males were observed entering the store with a black female that was identified as being as SS. Upon entering the store, the two black male suspects selected items from the store while the female (SS) exits the store immediately while attempting to shield her face. The two males then exit the store and the clerk is seen going to the door in an attempt to obtain a license tag from the vehicle. There

Before me this date personally appeared GRANIT, ADAM (582) who being first duly sworn deposes and says that on 22 day of October, (year) 2019 at 8121 SW 24TH CT 304, DAVIE, FL 33324 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

was no additional video in the area. Sunrise Detectives searched several of the complexes in the area looking for a black in color Dodge Challenger which met with negative results.

On March 22, 2019 flyers were created by the National Center for Missing and Exploited Children. These flyers were disseminated throughout Broward County, more specifically in areas where SS was last seen and locations where SS frequently visited.

On September 3, 2019 Brenda Mosely (Mother of SS) had received information that sexual explicit images of SS had been posted to several different websites, including; Per@scope, Pornhub, Modelhub and Snapchat. The posted videos depicted SS performing sexual acts on two unknown black male adults. SS is either fully nude and topless in all videos and performs oral sex and sexual intercourse in at least two of the videos. It was determined that approximately 58 pornographic videos of SS had been posted on the listed sites.

Preservation letters and subpoenas were completed by Sunrise Detectives. The preservation letters and subpoenas were sent to Per@scope, Pornhub and Modelhub.

On September 4, 2019, Brenda Mosely received pictures that were observed a Per@scope account (Naria920) and a Snapchat Account (prettyface). In the pictures SS was observed with a black male who fit the description of the black male suspect that were seen with SS on February 26, 2019. In two of the pictures SS is observed with a hand around her throat. A check of her Periscope account showed that the male in the video choking her was the same black male with bald head that was observed with SS at the 7-11

Before me this date personally appeared GRANIT, ADAM (582) who being first duly sworn deposes and says that on 22 day of October, (year) 2019 at 8121 SW 24TH CT 304, DAVIE, FL 33324 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
on **February 26, 2019.**

On October 14, 2019, Belinda Mosley provided information that a black Dodge Challenger was seen at the 7-11 located at 2399 S. University Drive Davie, Florida on October 13, 2019. Sunrise Police Detectives responded to the 7-11 and were provided with a Florida license tag, HFML12. A check of the Florida tag HFML12 revealed that it was registered to a Christopher Johnson, 8121 SW 24th Court, #304, Davie, FL 33324. Surveillance was conducted on this address by several detectives.

On 10/22/19 detectives observed SS and a black male subject leave the apartment at 8121 SW 24th Court, #304, Davie, FL 33324, and drive away in a black Dodge Challenger, FL Tag HFML12. Detectives followed the vehicle and made contact with SS and the black male driver, later identified as the defendant at 8970 SR 84.

During the interview with SS she stated that some of the videos that were posted on the Pornhub account Daddys_slut600 were of her and that they were taken while inside the apartment at 8121 SW 24th Court, #304, Davie, FL 33324. These videos consist of SS having oral sex with an adult male, having vaginal sex with an adult male, SS inserting a large object into her vagina, and SS digitally penetrating herself on the video. SS was also offering personal videos of herself performing sex acts.

SS stated that she has a mobile device inside the apartment at 8121 SW 24th Court, #304, Davie, FL 33324 that was used to film herself and post the videos on Pornhub and other social media sites. SS stated that she had sex with the defendant inside the apartment. SS advised that the sexual intercourse was video recorded and placed on

Pornhub. Under the Pornhub account Daddys_slut600, SS was able to identify the video of the defendant having sexual intercourse with her. The video is titled "My daddy fucking my sluty pussy".

The defendant provided his DOB as 12/7/88, which makes him 30 years old. The defendant denied having sexual intercourse with the victim.

On 10/23/19 a search warrant was executed at 8121 SW 24th Court, #304, Davie, FL 33324. Inside the apartment we found items belonging to the victim and paperwork from an abortion clinic. The victim stated that she got pregnant from the defendant and he took her to clinic to have an abortion.

The defendant was later transported to BSO Main Jail.
